FEMA

Mayor Walters announced the Borough of Avalon will be hosting a private meeting with FEMA on January 31, 2013 to discuss the new advisory ABFE Flood Maps and Elevations. This is for municipal employees only and will not be open to the public. Anyone who plans on attending is to let the Zoning Officer know and she will notify the officials in Avalon.

The new requirements are expected to have a substantial impact on increased premiums for a property's flood insurance policy. The new rules also call for new homes to be placed on pilings and not blocks, similar to homes in Hatteras, North Carolina. Board members expressed their concerns as this will affect the overall look of Stone Harbor.

The planning firm of Heyer & Gruel will be assisting the Borough in reviewing the new flood zones and building requirements.
