A RESOLUTION HONORING ST. MARY'S-BY-THE-SEA EPISCOPAL CHURCH FOR OVER ONE HUNDRED YEARS OF SERVICE TO THE PEOPLE OF THE BOROUGH OF STONE HARBOR

**WHEREAS,** "St. Mary's-By-the-Sea" Episcopal Church was established in 1910 after Stone Harbor founder David Risley donated land to build the church at 95th Street and Third Avenue; and

- **WHEREAS,** after decades of lobbying of diocesan officials by parishioners, St. Mary's Episcopal Church was designated a regular diocesan parish in 1967; and
- **WHEREAS**, today the parish of St. Mary's Episcopal Church has nearly 300 members led by The Rev. John Sosnowski since 1997; and
- **WHEREAS,** in 2007, St. Mary's Episcopal Church welcomed the Rev. Debra Bullock as assistant pastor and formed a partnership with St. Barnabas by the Bay Church in the Villas Section of Lower Township; and
- **WHEREAS,** St. Mary's Episcopal Church does a great amount of community outreach, including operating This 'N' That Thrift Shop in Rio Grande, which, with Heavenly Scavengers, helps to fulfill a need for affordable housing in Cape May County; and
- **WHEREAS**, also in 2007, St. Mary's and St. Barnabas formed "The Branches," an outreach center for fellowship, prayers and warm meals in Rio Grande; and
- **WHEREAS,** St. Mary's Episcopal Church continues to be a community anchor in Stone Harbor, drawing thousands to its Thursdays on the Lawn free summer concerts for the past 10 years, while ministering to the needs of parishioners and others; and
- **WHEREAS,** St. Mary's is celebrating its Centennial in 2010 with a celebration and dinner dance on Saturday, June 26 and a festive Eucharist on Sunday, June 27;
- **NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Stone Harbor, duly assembled in public session this 24<sup>th</sup> day of June, in the Year of Our Lord Two Thousand and Ten, that St. Mary's Episcopal Church, its pastors and parishioners, past and present, be and hereby are given the highest commendation by the Borough of Stone Harbor for their tireless service on behalf of the people of Stone Harbor and the people of Cape May County.
