The meeting was called to order by Mayor Walters at 4:30 p.m.

#### **PRESENT**

Mayor Walters announced that the meeting was now open. Adequate notice of the meeting was provided by posting a copy of the time and place on the Municipal Clerk's bulletin board and mailing a copy of same to the Press and the Cape May County Herald on January 5, 2011.

#### **REPORTS OF COMMITTEES AND OFFICERS**

**<u>PUBLIC SAFETY</u>** – Councilmember Cope reported that the Public Safety Committee met on June 16 and the Court stated that revenue is down approximately \$2,600 because there are less parking fines, but parking meter revenue is up about \$5,000. Councilmember Cope reported that the Fire Bureau conducted 954 rental inspections, 8 life hazard inspections, 241 re-inspections and revenue is up \$3,714 from this time last year. Councilmember Cope provided the police statistical report for the month of May as follows: 69 moving violations; 41 parking violations; 5 accidents handled; 6 suspicious vehicles; and 295 motor vehicle stops; 11 Ordinance violations; 19 adult arrests; 5 driving while intoxicated; 8 juvenile arrests; 19 medical emergencies; 6 fire calls; 4 alarms; 42 open doors/windows; 10 noise complaints; and 18 animal control complaints.

**NATURAL RESOURCES** - Councilmember Carusi reported that the rejuvenation project at the Bird Sanctuary is now in a "maintenance" mode; Bob Bartke has resigned as the Chair of the Bird Sanctuary Committee; docent guided tours are available on Sundays during the month of June and Saturdays and Sundays during the months of July and August. Councilmember Carusi reported that a contract has been signed with Ross Environmental Solutions for animal control, more specifically with the skunk issues and an Interlocal Agreement has been signed with Middle Township for all other animal control issues. Councilmember Carusi explained the process for reporting an animal control complaint, i.e., contact the police department. Councilmember Carusi asked Borough Engineer, Marc DeBlasio to give an update on the Beach Outfall Pipe Removal Project and Mr. Hawk to give an update on the Beach Replenishment Project. Councilmember Carusi thanked Mr. Hawk, the Mayor and the Public Works Department for all their hard work with respect to the Beach Replenishment Project.

BEACH & RECREATION - Councilmember Davies-Dunhour reported that \$507, 714 has been collected in beach tag revenue which is \$16,744 more than this time last year. Councilmember Davies-Dunhour reported that to date the Beach Patrol has had 2 water rescues, 1 EMS call, and 5 lost children; 18 new lifeguards were selected from the annual tryouts; and rookies are currently undergoing training; all returning lifeguards successfully passed running and swimming requalification tests and are certified in CPR, first aid and with AED; and the Department will be fully staffed by the end of the Month. Councilmember Davies-Dunhour reported that Blue & White Day was held on Friday, June 17 and was a great success; pre-season recreation programs have started and the full schedule of activities will begin on Monday, June 27; women's boot camp by PAC Fitness began on Saturday, June 18 and will continue on Mondays, Wednesday, Fridays and Saturdays at 8:00 a.m. through Labor Day; surf camp started on Monday, June 20; cardio corps is being held on Tuesdays and Thursdays at 8:00 a.m. and will start on June 28<sup>th</sup>; tai chi on Sundays and will start June 26<sup>th</sup>, and yoga on the beach will begin in July. Councilmember Davies-Dunhour reported that Channels 3 and 10 covered our beach opening ceremony on Thursday, May 26<sup>th</sup>, the Turtle Trot had over 525 runners and walkers and results were posted by that afternoon because we hired a timing company that uses a computer chip to record times; the Tourism Director is currently working on media and coordination of the Farmer's Market on Sundays, 4<sup>th</sup> of July events, the Flyers Trial on the Isle on July 8<sup>th</sup>, the Baby Parade on July 18<sup>th</sup> and the JAWS Youth Fitness Festival on July 31, 2011; and continually updating the Calendar of Events and Channel 2.

**<u>UTILITIES</u>** - Councilmember Kramar reported that the sewer main at 28 84<sup>th</sup> Street was repaired; the water valve at 85<sup>th</sup> Street and First Avenue was replaced; water meter "ert's" are being replaced; and a clogged sewer pump at 114<sup>th</sup> Street was repaired. Councilmember Kramar reported water pumped in May was 16,700 million gallons compared to 21,486 million gallons in May, 2010. Councilmember Kramar reported that all the sprinklers are on and being checked as necessary and run Mondays, Wednesday and Fridays for 26 minutes in the morning and 26 minutes in evening, and there were a total of 57 mark outs for the month of May. Councilmember Kramar reported that the Utilities Committee produced a yellow Notice (door tag) which will be placed on residences whose irrigation systems are running excessively.

**PUBLIC WORKS** – Councilmember Mastrangelo reported that vehicle ramps and cross-overs are being regraded after the dredge work and the beach raking has commenced 7 days per week; the firehouse roof replacement is almost complete; the department is fully staffed this season; Special Event activities included 9.75 hours for the Beach Opening Ceremony, 33 hours for the Turtle Trot, 52.5 hours for Memorial Day, 83.5 for the Boat Show, 6.75 hours for the Yard Sale and 2.5 for the Bridge Dedication at the Bird Sanctuary; the playground equipment at 82<sup>nd</sup> Street is being sanded and repainted and fibar was installed at all the playgrounds including the school; the 119<sup>th</sup> Street handicapped ramp is being redesigned and replaced; and Borough properties have been cleaned and mulched. Councilmember Mastrangelo reported that the second Bulk Trash pick up day resulted in 7 trips totaling 37 tons of trash compared to 11 trips totaling 54 tons in May of 2010; the summer trash schedule began yesterday and runs through September 10<sup>th</sup>, and the solid waste tipping fees for the month of May were \$9,689.32 compared to \$14,670.76. Councilmember Mastrangelo reported that the next scheduled bulk days at Monday, September 19<sup>th</sup> and Monday, November 14<sup>th</sup>.

<u>ADMINISTRATIVE & FINANCE –</u> Councilmember Vaul reported that the budget, revenue and expenses show no significant variances; A & F Committee met and discussed many issues including the Library and the Administrator recruitment plan. Councilmember Vaul stated that the A & F Committee has met with 5 possible Borough Administrator candidates so far and a few more interviews will be scheduled in the next week or two and plans on having a list of potential candidates for full Council to meet with in July. Councilmember Vaul reported that the audit is complete and the auditor is scheduled to meet with A & F within the next week or two.

Mr. Hawk reported that last Thursday the dredge company finished pumping sand and are in the process of removing the pipes and equipment; however, the trucks can only truck loads out during daylight hours because they are oversized and have certain restrictions; there will still be beach closings (1 access at a time) for gravel, fencing, and dune grass plantings.

**ENGINEER'S REPORT** - Mark DeBlasio, Borough Engineer, provided the Engineer's report as follows:

# Beach Outfall Elimination Project – Phase 2 & Phase 3 Preliminary Assessment

- Applications to U.S. Army Corps of Engineers, NJDEP CAFRA and Waterfront Development & NJEIT have been submitted and are under review.
- Public Comment period ends June 25, 2011. Notice of Public Comment has been published in the Atlantic City Press and mailed to property owners within 200' feet of the beach outfalls and bulkheads.

# **<u>114<sup>th</sup> Street Generator Installation</u>**

- Design is underway and a preliminary layout has been sent to the Borough for review.
- Construction is scheduled for Fall 2011.

# **Replacement of the Boat Ramp at Bay Marina Park**

• The project is completed and the ramp was opened for Memorial Day weekend.

# **Replacement of the Firehouse Roof**

- Construction is underway.
- The roof replacement portion of the project to be completed by June 24, 2011.
- Project completion date is August 5, 2011.

# FY 2010 NJEIT Sanitary Sewer and Water Main Improvements

- All work is completed on Corinthian Place, 98<sup>th</sup> Street, Sunset Drive and Pennsylvania Avenue.
- The contractor will return to complete the project in September.
- **Public Works Building Painting and Metal Repair Phase III**
- A Pre-Bid meeting will be held June 21, 2011.
- Bid opening date is July 7, 2011.

# **Street Opening Ordinance**

- The new street opening ordinance was finally adopted at the June 7<sup>th</sup> Council meeting.

# **COMMUNICATIONS**

# HEARING OF THE PUBLIC ON MEMORIALS, RESOLUTIONS, PETITIONS & COMPLAINTS

Roy Thompson – 8201 Second Avenue – inquired abut the new Rec Building and whether Council has given any further thought to moving the pavilion. Mr. Thompson was advised that there are no plans to move the pavilion. Mr. Thompson complained about some groups who are using the field are consuming alcohol and throwing cans, bottles, trash around. Mr. Thompson was advised that he should contact the Police Department when this is happening.

Bunny Parzych – 9925 Sunset – stated that Mr. Carusi spoke at the ROA meeting about the library and indicated that it is all about "emotion;" however, for her it is about cold hard cash. Mrs. Parzych indicated that there is nothing emotional about \$1.4-\$1.5 million per year. Mrs. Parzych inquired about the lot on Second Avenue which could be utilized for parking if the library was built there, and was advised that the Borough does not own that property. Mrs. Parzych stated that the tax rate given by the County representative at the last meeting was incorrect (2.9), but it is really 3.1%. Mrs. Parzych requested that members of Council to look at Avalon and Ocean City's Library websites.

Mr. Donohue commented that there have not been any discussions about the library by Council as a whole, but a closed session is on the Agenda tonight. Mr. Donohue stated that for the Borough to back out of the lease now, the Borough would face a host of legal issues. Mrs. Parzych inquired about the lease. Mr. Donohue stated that the lease will be part of a closed session discussion tonight, but commented that the lease is a 15 year lease with a 15 year renewal option. Mrs. Parzych inquired again about the Borough pulling out of the County system and having its own library system. Councilmember Vaul stated that a lot of research and a significant amount of time and discussion went into this project by each member of Council. Councilmember Vaul stated that the Borough does not have the ratables that Avalon has and therefore, would be unable to duplicate Avalon's library.

Charles Koch – 236 85<sup>th</sup> Street – inquired about the parking fees at the 95<sup>th</sup> Street beach. Mr. Koch was advised that new kiosks were ordered but have not been delivered yet and that as soon as they arrive, Public Works will install them. Mr. Koch inquired about new legislation which would permit Avalon to return library taxes to its taxpayers.
