REPORTS OF COMMITTEES AND OFFICERS

PUBLIC SAFETY – Councilmember Cope reported that the Public Safety Committee met on July 14 and topics discussed are as follows: a decrease in parking violations revenue for the Court; parking tickets issued this year are 156 compared to 664 this time last year, as a result of the decrease in revenue, part-time Court personnel are not working extra hours to process violations; the Court is investigating the purchase of a new sound system. Councilmember Cope reported that an evacuation workshop has been scheduled and members of the Office of Emergency Management will be attending; the Committee is recommending amending the Beach Vehicle Permit ordinance and the introduction is scheduled for tonight. Councilmember Cope asked Fire Chief Stanford to report on a recent rescue on the beach. Chief Stanford gave his statistical report for the month of June which includes 147 inspections, 13 life hazard inspections, 15 smoke detector inspections, and 41 reinspections, the Fire Co. had 14 fire calls, 1 meeting, 2 special details, 4 mutual aids, and 28 EMS calls. Chief Stanford explained how a 67 year old experienced cardiac arrest on the 108th Street beach and a bystander administered CPR, EMS was dispatched and CPR was being performed and the AED was being attached, and the patient coded several times and was shocked several times, and ultimately, the patient survived and is doing well. Chief Stanford explained that had it not been for the AED, this individual would definitely have passed. Chief Stanford stated that as a result of everyone working so incredible well together (Lifeguards, EMS, Police, Fire) this patient survived. Chief Stanford stated that he is recommending that all AEDs in Police and Fire Departments should be the same model as well as starting an AED public access program with the installation of AEDs in all of the Borough's buildings. Councilmember Cope provided the statistical report for the Police Department for the month of July which is as follows: 85 moving violations; 113 parking violations; 7 accidents handled; 4 suspicious vehicles; and 312 motor vehicle stops; 41 Ordinance violations; 34 adult arrests; 7 driving while intoxicated; 19 juvenile arrests; 29 medical emergencies; 12 fire calls; 7 alarms; 43 open doors/windows; 13 noise complaints; and 32 animal control complaints.

NATURAL RESOURCES - Councilmember Carusi reported that the Natural Resources Committee met on July 15, 2011 and the highlights are as follows: Bird Sanctuary is now in a "maintenance" mode; some of the plants in the memorial gardens are dying and will be replaced; there were 13 docent lead tours; the Engineer is in the process of securing all the necessary permits for the outfall pipe removal project; beach replenishment is complete and the cross-overs are complete and the sand fence will be installed shortly and the dune grass will be planted in the Fall; there were 17 dog, 2 cat, and 8 skunk reports for Animal Control; and at a recent meeting with the DEP, the DEP praised Stone Harbor for its beach access plan.

BEACH & RECREATION - Councilmember Davies-Dunhour reported that the Beach, Rec and Tourism Committee met on June 23. Councilmember Davies-Dunhour reported that the revenue for the beach tags is up \$26,632 over last year and in 2011 there were 92 less seasonal tags sold, however, the weekly tags are up by \$284 and the daily tags are up by \$386. Councilmember Davies-Dunhour asked Lifeguard Captain, Sandy Bosacco, to give his monthly report. Captain Bosacco reported that during the month of June there were 6 rescues, 5 EMS calls, 13 lost children, 2 hobie cat assists, and 2 police assist calls. Captain Bosacco stated that the Annual Mascot Races will be on August 6. Captain Bosacco reported that the beach has been very crowded this summer and the guards have been performing very well. David Smith, for Rec Director Van Cathcart, reported that sports clinics are leagues are very well attended, arts and crafts have over 50 kids every day, yoga on the beach, boot camp, cardio corps, tennis, and other sports camps like lacrosse and soccer are also very well attended. Mr. Smith reported that every Wednesday in the Park there is either a movie or music and these events are well attended too. Joann DelVescio, Tourism Director, reported on the baby parade, coverage on press releases, preparing for photo shoot at the end of the month, Channel 2, hosted a group of tour guides, production of a flyer with a list of things to do in Stone Harbor which was distributed to all realtors, hotels and campgrounds, ads in the Shore Guide, Family Night on Mondays, Flag Lowering Night on Tuesdays at the Marina, Trial on the Isle, Jaws Fitness Festival, Barbeque and Blues Festival on August 3 and tickets are \$20 for adults and \$15 for children and \$25 for adults on the day of and \$20 for children on the day of, Arts and Crafts Show, and the Shiver in 2012. Mrs. DelVescio also reported that Cathy Orr from Channel 3 will be here on Thursday, July 21 to film her 125th Orr at the Shore segment.

<u>UTILITIES</u> - Councilmember Kramar reported that a sewer sinkhole was repaired at 9011 Second Avenue, water meters were read, the kitchen faucet at Public Works was replaced; and a new motor was installed on Pump #1 at the Water Plant. Councilmember Kramar reported that there were 50 mark-outs during the month of June, wells and lift stations are maintained, sanitary sewers are checked and cleaned, water and sewer services installations are done as ordered, and water quality samples are taken daily. Councilmember Kramar reported water pumped in June was 31.379 million gallons compared to 34.243 million gallons in June, 2010. Councilmember Kramar reported that the Committee is working on scheduling a meeting with Comcast, Atlantic Electric and Verizon to address issues with the utility poles.

PUBLIC WORKS – Councilmember Mastrangelo reported that the 119th Street handicap cross-over has been renovated and boardwalks were installed at 83rd, 88th, 95th, 101st, 111th and 119th Streets. Councilmember Mastrangelo reported that a total of 428.75 man hours were utilized for Special Events including the Sister Blister, Fourth of July, Trial on the Isle, Antique Show and the Farmer's Market and Flag Lowering Ceremonies. Councilmember Mastrangelo reported that the roof at the Fire House is almost complete, and the new kiosks have been installed at the Beach Lot and the Water Tower Lot and are working properly. Councilmember Mastrangelo reported that a Risk Management company was here and conducted a site survey of the grounds crew while they were cutting the traffic islands on 2nd Avenue and were very impressed with entire operation and may use some of the photos taken during the survey as part of a safety video they are developing. Councilmember Mastrangelo reported that the litter patrol picked up 84 bags on trash during the month of June; the solid waste tipping fees for June 2011 were \$17,680.12 down \$1,979.24 or 10% over June, 2010; and the summer trash schedule began June 19th and runs through September 10th. Councilmember Mastrangelo reported that the next scheduled bulk days are Monday, September 19th and Monday, November 14th.

<u>ADMINISTRATIVE & FINANCE</u> — Councilmember Vaul reported that the top candidates for the administrator position have been identified and are scheduled to meet with the entire Council on July 30. Councilmember Vaul reported that the A & F Committee met with the auditors and they have issued a clean audit. Councilmember Vaul reported that things look favorable regarding the budget and under-spending has been offsetting any revenue shortfalls.

Councilmember Kramar reported that the Shade Tree Committee is working on a Tree Management Plan.

ENGINEER'S REPORT - Mark DeBlasio, Borough Engineer, provided the Engineer's report as follows:

<u>Beach Outfall Elimination Project – Phase 2 & Phase 3</u> Preliminary Assessment

- Applications to U.S. Army Corps of Engineers, NJDEP CAFRA and Waterfront Development & NJEIT have been submitted and are under review.
- Public Comment period ended June 23, 2011. No comments were received from the public regarding the application. NJDEP has accepted the Individual Permit Application as being complete for final review. The deadline for decision on the application is August 21, 2011.
- Public Hearing per NJEIT requirements was held July 15, 2011.
- NJDEP Bureau of Water Systems has issued the construction permit with a permit expiration date of July 15, 2016.

114th Street Generator Installation

- Design is underway and a preliminary layout has been sent to the Borough for review.
- Construction is scheduled for Fall 2011.

Replacement of the Firehouse Roof

- The contractor is awaiting the fabrication and delivery of the louvers. The remaining work includes repair of the brick chimney and installation of the louvers. Both tasks will be due concurrently as the same equipment is needed to access both work areas.
- Project completion date is August 5, 2011.

FY 2010 NJEIT Sanitary Sewer and Water Main Improvements

- All work is completed on Corinthian Place, 98th Street, Sunset Drive and Pennsylvania Avenue.
- The contractor will return to complete the project in September.

<u>Public Works Building Painting and Metal Repair – Phase III</u>

• Bids were opened on July 7, 2011 and are currently under review by the Solicitor.

83rd Street Recreation Support Center

• Our office is providing civil/site engineering design services for the project. We have completed our portion of the plans and specifications and have transmitted those documents to the project architect.

RESOLUTION OPPOSING S-2795 AND A-3835, CONCERNING ENFORCEMENT RESPONSIBILITY OF STATE HOUSING CODE UNDER THE "HOTEL AND MULTIPLE DWELLING LAW"

WHEREAS, on June 29th S-2795 passed the State Senate by a vote of 23-13-4, and now rests with its Assembly companion, A-3835, with the Assembly Housing and Local Government Committee; and

WHEREAS, S-2795 and A-3835 would prohibit municipalities from adopting ordinances requiring periodic inspections of multiple dwellings other than those conducted by the State under the "Hotel and Multiple Dwelling Law"; and

WHEREAS, S-2795 and A-3835 would prohibit municipalities from charging separate fees for the registration of multiple dwellings; and

WHEREAS, according to a fiscal estimate prepared by the non-partisan Office of Legislative Services S-2795 and A-3835 will decrease municipal revenues and potentially decrease municipal expenditures; and

WHEREAS, S-2795 and A-3835 would eliminate local control over the inspection of multiple dwellings which is not in the public's best interests; and

WHEREAS, landlord registration of any rental unit, regardless of whether a portion is owner-occupied could continue but a municipality would be prohibited from charging a registration fee thereby raising cost without any revenue off-set; and

WHEREAS, municipalities could continue to issue "Continuing Certificates of Occupancy" upon an inspection following termination of occupancy in a rental unit, but would be preempted by the bill from having or adopting ordinances under which periodic inspections of multiple dwellings would be made; and

WHEREAS, such landlord registrations and "Continuing Certificates of Occupancy" are conducted for the public safety and welfare of the citizens of our municipality;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Stone Harbor that enactment of S-2795 and A-3835 will decrease municipal revenues and place yet another financial burden on already strained New Jersey Municipalities, and will take away local control over the inspection of multiple dwellings, which is not in the best interest of our residents.

BE IT FURTHER RESOLVED, the Governing Body of the Borough of Stone Harbor strongly opposes S-2795 and A-3835;

BE IT FURTHER RESOLVED, that a copy of this resolution be transmitted to the Governor of the State of New Jersey, State Senator Jeff Van Drew, Assemblyman Nelson Albano, Assemblyman Matt Milam, Assemblyman Kevin Ryan, Assemblywoman Mila Jasey, Assemblyman Joseph Cryan, Assemblyman Jerry Green and the members of the Assembly Housing and Local Government Committee, Assembly Speaker Sheila Oliver, Senator Steven Oroho, Senator Jeff Van Drew and the New Jersey State League of Municipalities.
