MINUTES OF THE WORK SESSION OF MAYOR AND COUNCIL OF THE BOROUGH OF STONE HARBOR HELD IN THE MUNICIPAL BUILDING, JUNE 5, 2012

The meeting was called to order by Mayor Walters (Avery Panico) at 4:30 p.m.

Mayor Walters introduced Avery Panico who is acting Mayor for the Day. Mayor Walters explained that Avery's parents won a bid at a PTC Fundraiser. Mayor Walters welcomed Ms. Panico.

ORDINANCE 1405 - Planning Board Recommendations - Outdoor Dining

Mayor Walters explained that when Council adopted the Outdoor Dining Ordinance a few years ago, if a business was interesting in having outdoor dining, they would have to go before the Planning Board for Site Plan Approval and this proposed ordinance is an attempt to pare down these requirements so business owners would not have to go through the expensive process of Site Plan approval. Mayor Walters explained this ordinance would create an Outdoor Dining section to the Zoning Ordinances and would provide regulations such as no table service, the table is 27" or less in length and in width or 30" or less in diameter and one table for each 32 square feet of ground area or 4 tables, and no consumption of alcohol. Councilmember Kramar indicated that she has concerns such as Harbor Square which has 19 units and if each unit were a restaurant, there could be up to 76 tables outside. Councilmember Kramar stated that she is 100% in favor of outdoor dining, but who will control and/or enforce this ordinance. Mayor Walters responded that the Planning Board is considering a permit process where an applicant would come in and pay a nominal fee for a table permit. Councilmember Rich stated that this is a friendly beginning at an attempt to do something that will be beneficial to our commercial community. Mr. Donohue indicated that the ordinance provides for a maximum of 4 tables per unit.

A RESOLUTION AUTHORIZING A BENCH DEDICATION PROGRAM

WHEREAS, the Borough of Stone Harbor is desirous of establishing a Bench Dedication Program in specific areas of the Borough; and

WHEREAS, the Borough Council has determined that it would be in the best interests of the Borough and its residents and visitors to provide additional enhancements in the nature of benches; and

WHEREAS, the Borough Council has also determined that it would benefit both the Borough and its residents and visitors to offer the opportunity for members of the public to dedicate benches installed in the Borough for use by the general public; and

WHEREAS, the Borough has determined that it is the best interest of the Borough to implement a bench dedication program which provides that the Borough shall select the style and color of the benches and further provides a consistent method for the selection of locations and the establishment of amounts to be paid to dedicate benches.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Stone Harbor, in the County of Cape May, State of New Jersey, as follows:

- 1. The Borough hereby establishes a bench dedication program which shall be administered in accordance with the following procedures:
 - a. Any member of the public who wishes to dedicate a bench to the Borough shall submit a written application on the form attached hereto. All applications must be submitted with payment no later than January 1st to ensure installation for the following summer. Benches will be installed by the Borough in May or as soon thereafter possible for the upcoming summer.
 - b. Any applications submitted after January 1st of each year will be processed at the convenience of the Borough. There will be no guarantee of installation by the upcoming summer months.
 - c. Each applicant shall provide his or her name, mailing address, telephone number and if available, e-mail address.
 - d. The design, materials and color of all benches shall be determined by the Borough.
 - e. The amount of the fee shall be \$1,500.00 for each bench dedicated. Upon request of the applicant, the Borough shall provide a written receipt. All benches shall be the property of the Borough.
 - f. Locations of benches shall be at the 81st Street Marina, the 80th to 83rd Street Promenade, 95th and First Street Parking Lot and 123rd Street and Second Avenue. Each applicant shall designate on the application the desired location for the bench dedicated.

- g. Each applicant may also submit a note of dedication or message to be included on the front of the bench, which message shall be no longer than thirty (30) characters. For an additional fee of \$95.00 applicant can receive up to an additional thirty (30) characters. Engraving is epoxy filled. The Borough reserves the right to reject any proposed message which the Borough determines to contain lewd, lascivious or objectionable language. No messages will be permitted which contain any disparaging comments about any individual or public entity.
- h. Requested locations will be awarded on a first come, first serve basis. Applicants will be notified in writing of the location they are assigned and must submit payment within thirty (30) days of the date of such notice. Failure to submit payment within the designated time shall result in forfeiture of the location. Submission of payment shall be considered approval of the location designated y the Borough. The Borough reserves the right to change the location of benches in order to achieve optimal location and bench distribution.
- i. The Borough shall install and maintain each bench at the Borough's expenses for a period of ten (10) years from the date of the application. At the end of the ten (10) years, the donor can file a application for a new bench or the location will be offered for dedication by other members of the public.
- j. All applications shall be submitted to the Borough's Administrator or designee.
- 2. The Borough reserves the right to amend or terminate the bench dedication program at any time.

BE IT FURTHER RESOLVED that this resolution shall take effect immediately.

DISCUSSION:

Hawk Haven Vineyard at Farmer's Market. Mr. Donohue explained that Hawk Haven is a local winery that wants to sell wine (and tastings) at the Borough's Farmer's Market on Sunday mornings. Mr. Donohue explained that Ordinance 134-9 prohibits alcohol consumption in public except where Borough Council may approve a permit for the use of Borough property for the consumption of alcoholic beverages in connection with a special event. Mr. Donohue stated that State Regulation 13:2-10.2 which allows a licensed winery to sell their product off-premises with a license from the Division of Alcoholic Beverage Control. Mr. Donohue indicated that Hawk Haven would be required to get the permit from the State, but the Borough would have jurisdiction over whether or not they wanted to permit the sale of wine at the Farmer's Market as well as require a Certificate of Insurance. Mr. Donohue stated that the Borough also has a time restriction for the sale of alcohol which would prohibit the sale of alcohol prior to 11:00 a.m. on Sundays. Mrs. Wannen (Famer's Market Manager) stated that the rules for the Farmer's Market require vendors to be set up by 8:00 a.m. and Hawk Haven would have to be set up by 8:00 a.m., but then would not be permitted to sell any wine until 11:00 a.m. After some discussion, it was agreed that we would invite Hawk Haven to the next Council meeting.

<u>Library Location Committee Update.</u> Councilmember Rich reported that the Library Location Committee will have its recommendation ready for the June 19, 2012 Meeting. Councilmember Rich stated that cut-off date for opinions of the location of the library was May 31, 2012 and the Committee has gathered all the information available in order to make this recommendation.
